4. All proof of financial support must be original documents submitted in English. The date the document was issued and the amount in US dollars must be clearly indicated.
5. Please be aware that evidence of financial support must also be shown to the U.S. Embassy or Consulate when applying for a visa. Therefore, you will need to have two sets of financial support documents—one to submit to the University of Pittsburgh and one for the U.S. Embassy or Consulate.
6. Students may provide proof of financial support from more than one sponsor. The attached form should be copied and provided to any additional sponsors.
